## IN MEMORY of A *LIFE* THAT ENDED TOO SOON



**T**he Mya Lin Terry Foundation donated \$300,000 in support of the Michael Fux Family Center at The Unterberg Children's Hospital at Monmouth Medical Center. In recognition of this generous donation, the movie cinema in the Michael Fux Family Center will be named The Mya Lin Terry Cinema.

Named for Mya Lin Terry, a 10-year-old Ocean Township girl who passed away in 2013 after battling cancer for more than five years, The Mya Lin Terry Foundation is a charitable, non-profit organization created to honor the memory of Mya Lin by enriching the lives of pediatric cancer patients' experiences with hope, love and joy while creating awareness for, and supporting new treatment options leading to cures for pediatric cancer patients.

"I am humbled by the generosity and support of so many friends, family and community members that have made this gift, in Mya's name, possible," said Kelly L. Terry, Mya's mom and president of The Mya Lin Terry Foundation. "Having spent half of Mya's life in the hospital, we wanted to give back not only to Monmouth Medical Center for their kindness and care of Mya, but to all the children and their families who will enter these doors. It is our hope that we help ensure that all children are able to enjoy their childhood, despite health battles they may be facing."

Constructed to look like a traditional public movie theater and equipped with state-of-the-art technology, acoustics and a popcorn machine, The Mya Lin Terry Cinema will have an intimate setting with approximately 20 plush movie theater-style seats and will be wheelchair accessible. The movie cinema will provide families, siblings and their friends with an opportunity to replicate going to the movies, where they can relax, take their mind off their family's challenges and escape for a few hours.

This generous donation keeps Mya's memory alive while helping patients and their families find joy as they face their own challenges. The Mya Lin Terry Cinema will relax and refresh children and families and promote healing – all part of our commitment to support and empower those we serve. ■

# ENRICHING the LIVES of CHILDREN

The Unterberg Children's Hospital at Monmouth Medical Center received a \$1 million donation from philanthropist and successful Florida businessman, Michael Fux and the Michael Fux Foundation, to establish the Michael Fux Family Center.

Rising from humble beginnings in Cuba to become CEO of Comfort Revolution, a distributor and marketer of comfort sleep products with a location in West Long Branch, Mr. Fux created two charitable foundations to help those in need. He established the Michael Fux Foundation in 2006 with the mission of enriching the lives of underprivileged children with serious illnesses.

The Michael Fux Family Center at The Unterberg Children's Hospital will be modeled after the Michael Fux Family Center at Miami Children's Hospital (MCH) and will provide a safe, non-clinical environment for the families of children receiving care and will offer peace and respite. It will provide dedicated space for parents, patients and siblings to interact with each other as a family, despite the medical challenges faced by their child. Features of the Michael Fux Family Center will include a full kitchen and dining area, family room, private breast-feeding room, showers, laundry facilities, a movie theater, children's library, computer rooms, a performance arts center, a gym and a massage therapy room. Construction is set to begin in 2015.

"I am thrilled to embark on this project and partner with Monmouth Medical Center to create the Michael Fux Family Center at The Unterberg Children's Hospital," said Mr. Fux. "I look forward to enriching the lives of the children being treated here as well as their families. I know from my experience that this is a wonderful service and opportunity."

"We are extremely thankful to Mr. Fux and the Michael Fux Foundation for this generous and transformative gift. It will help to ensure that The Unterberg Children's Hospital continues to fulfill its mission of providing family-centered, comprehensive care to all of our young patients while providing a supportive environment for families," said Frank J. Vozos, MD, FACS, president and chief executive officer of Monmouth Medical Center.

"This gift will truly have a tremendous impact on the children being treated at The Unterberg Children's Hospital and their families," said Tara F. # COMMITMENT

Auxiliary groups provide supplementary or additional help and support. This is certainly true for the Henry Pollak Auxiliary, which has been raising funds in support of Behavioral Health Services at Monmouth Medical Center since the 1970's. These talented women hosted the hospital's very first crystal ball and held holiday parties at what used to be known as auxiliary hall. Over the years, the group's size and dynamic changed but their mission never wavered; even today they remain committed to helping those in need of mental health services. Considering that 1 in 4 Americans suffer from a mental health disorder at some point in their lives makes this an essential endeavor.

Fortunately, 70-90% of individuals who receive treatment see an improvement in their symptoms and quality of life. And thanks in part to the efforts of our auxiliarians, help is available right here in the community. Monmouth Medical Center Behavioral Health Services include comprehensive mental health programs for children, adolescents and adults diagnosed with psychiatric and dual disorders. All programs are led by a multidisciplinary staff of experienced professionals who have advanced training and certification in all facets of behavioral health.

The department provides services to all those in need of mental health care especially the most marginalized population of those who are chronically and persistently afflicted with mental health issues. Services include crisis intervention, inpatient care, short-term care, partial hospitalization, intensive outpatient programs and traditional outpatient care.

The auxiliary is dedicated to supporting the enhancement of our behavioral health services, particularly the Pollak Clinic, which offers a full range of behavioral health services on an outpatient basis and served almost 3,000 individuals last year. This is in addition to the 6,350 emergency outreach calls the behavioral health team responded to, 2,057 of which were for individuals under the age of 18; the 847 children and adolescents admitted to the inpatient psychiatric unit; and the hundreds of inpatient adults treated each year.

The core group of women pictured have been together since the 1980's. They've hosted cocktail parties, Valentine's Day parties, 50/50 raffles, pool parties, and smaller home events. Today's group hosts two primary events each year – a holiday party and a summer cocktail party – as well as monthly business meetings. Their tireless efforts have provided over \$130,000 directly to behavioral health services over the years, which has enabled the staff to enhance patient services, provide new programs, conduct minor renovations, and generally improve the patient experience.

The unwavering commitment of the Henry Pollak Auxiliary is applauded at Monmouth Medical Center, where the entire behavioral health staff and the patients who benefit from the auxiliary's work are extremely grateful for the years of hard work and dedication by its members in support of our services. The Auxiliary is now accepting new members. They also hope to see you at their **spring cocktail party on May 28 at 5:30 at Edgewater Beach Club, Sea Bright, NJ. 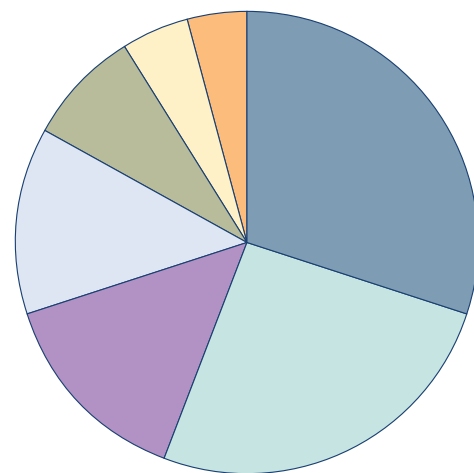
### **There are several ways to make your gift:**

# 2014 ANNUAL FINANCIAL REPORT

This Annual Report documents the generous support of many donors who made gifts from January 1, 2014 to December 31, 2014. During this period, **Monmouth Medical Center Foundation raised \$6,001,474\*** (including \$670,794 in public grants that are funded directly to the hospital from the state of New Jersey). At year-end 2014, the Foundation's total assets were **\$30,773,035**. The Foundation had an excess of income from operations of **\$2,785,535\***. Contributions consisted of cash and pledges in support of the capital campaign, annual campaign, major gifts, planned gifts and bequests, special events and grants. The chart below shows this in greater detail. During 2014, the Foundation transferred **\$5,023,838** to **Monmouth Medical Center** in support of the hospital's various projects, programs and services as illustrated in the chart below.

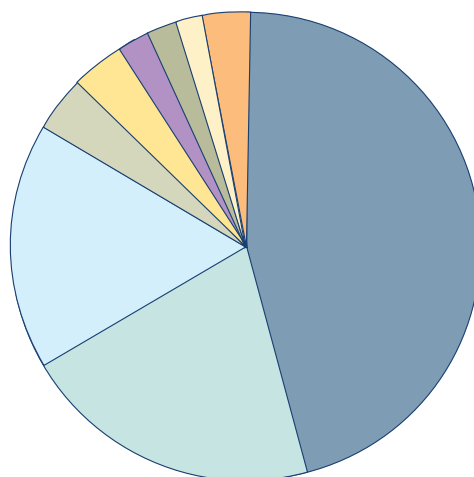

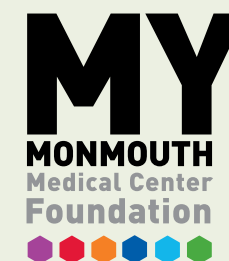

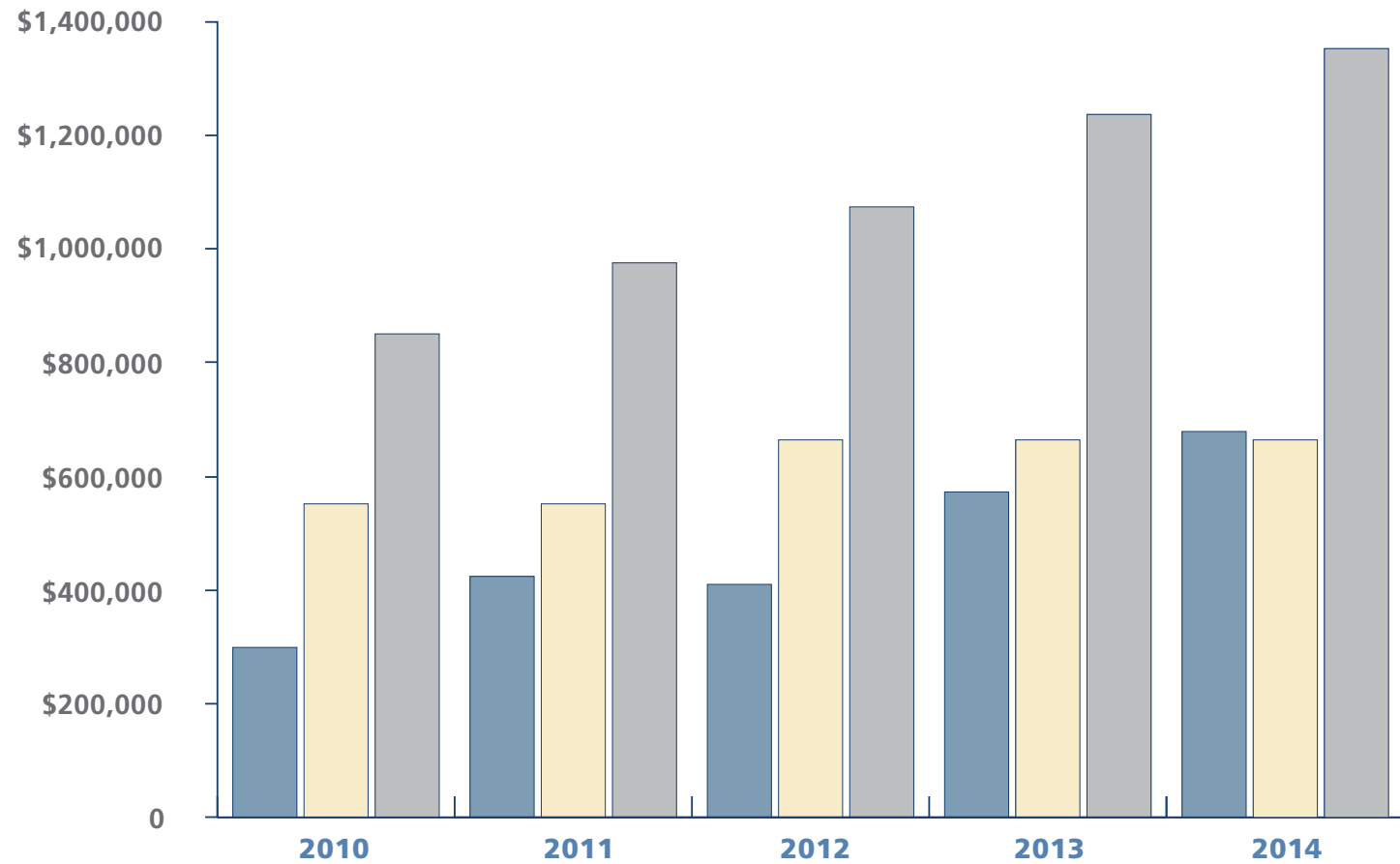

## GRANT SUMMARY

An upward trend continued in 2014 within our grant portfolio thanks to our outstanding medical staff, exemplary programming, and the dedicated efforts of our grant professionals. Revenue from grants totaled \$1,361,690 from both public and private grants for an increase of 9% from 2013.
